

1 BOA Reserved Token of Emancipation = 10^{Googolplex} USD

(BOA Reserved) is the physical manifestation of our Ancestor's intrinsic value as human beings. To be valued according to the system of BOA Me (ALL for 1&1 for ALL). Just as each human being is a priceless ultra-rare specimen, all BOA Reserved are created equally. Representing 1 Humanity. **The value of each BOA Reserved is up to but not limited to 1 Googolplexian USD (United States of America Dollars) further understood as the “Universal Standard Denomination.”** The number “Googolplexian” is expressed as $10^{\text{Googolplex}}$, a large number impossible to write, or physically measure. Just like the value of each human being. However, **it can be calculated, and or artistically expressed.**

BOA Reserved is the world’s first manmade Googolplexian. Googolplexians exist in nature like seeds, plants, and animals. Within each seed is a literal whole forest. Every living organism contains the DNA of every previous ancestor in their bloodline. Within every cell is the whole organism via DNA, the value of (All for 1&1 for All). All natural Googolplexians can reproduce themselves indefinitely naturally under the right conditions. In the wrong conditions, a seed will lie dormant for 1000 years and life will fail to thrive.

BOA Reserved is a manmade Googolplexian, **it depends on manmade conditions to produce what humans need. BOA Reserved is powered by love and reciprocation thereof.** Love for humanity, and preservation of life. BOA Reserved is for human needs and development, trade, food, shelter, education, and business development. A proverbial financial seed that can be nurtured and grown into a crop of choice.

The Economic System of BOA ME

BOA Me is an “Economic System” Also Known as “Googolplexian Economics” (Guo-plex-ian). Using a Googolplexian Token, as capital. **“Googolplexian Tokens” represent a point of reference for the great value of priceless variables such as a Human Being, Time, and Life itself.**

Example: Employees pay themselves; employers receive free or low-cost labor, and the Government gets maximum Tax revenue. Governments can charge a “Reparations Tax” to collect “Reparations revenue” to use “Googolplexian Tokens”.

Time becomes a source of capital to be leveraged by the holder(s). The system depends on all participants to produce a good or service. Googolplexian Tokens can be connected to Labor-Union-like groups, guilds, Cities, Counties, and neighborhoods. A major proponent of Chattel Slavery was the inability to determine your personal value.

ALL must pay Taxes and/or Fees in Government currency when exchanged for National fiat, to be determined by the Government.

Our method of Finance (System of BOA Me) is akin to crude oil refinement. Googolplexian-Tokens are raw capital as crude oil is to gasoline. BOA Me is sustainable finance, for sustainable development. Sustainable development is unsustainable if financed by unsustainable resources, i.e., gold, oil, or printing more fiat currency. **Access to sustainable capital will yield sustainable development.** Accepting our sacred capital will support our recovery from Chattel Slavery and Systemic Racism and yield sustainable development for the U.S. for generations.

BOA Reserved is issued by The Decentralized Bank of BOA Me, as capital for The Great Nation of BOA Me, to serve as a medium of foreign exchange and trade. The Supreme Council of BOA Me determines the standard value of (BOA Reserved). The holder determines the value according to needs, not limited by the standard value established by the Supreme Council of BOA Me. BOA Reserved is the physical manifestation of the Digital BOA Me Token removed from circulation, to be transferred via the BOA Transfer Agreement. The value and use of digital BOA are established by “The Emancipation Treaty of BOA Me”.

Each series of BOA Reserved will be dated by a different year AFTER CAPTIVITY (A.C.). The first series is notated at 1 (A.C.), equal to 2023 (A.D.). 2023 (A.D) is our first year after “ECONOMIC CAPTIVITY”. Subsequent series will be labeled according to the year commissioned ex. 2024 (A.D) is series (2 A.C.), 2028 (6 A.C.), etc. Not Guaranteed to make any more series.

The Decentralized Bank of BOA Me (DCB)

The Decentralized Bank of BOA Me (DCB) is a sovereign Institution. Establish on Earth February 20, 2022, according to God-given inherent sovereignty. The Supreme Council of BOA Me governs (DCB). **Born from the need to recover from Chattel Slavery, systemic racism, and poverty as a Nation.** We seek to use our painful experience for the **“Greatest Good of Humanity.”** DCB creates Googolplexians for foreign exchange and as a medium of trade. **A Googolplexian is raw capital, as crude oil is to gasoline.** More Googolplexian will be made as needed per The Supreme Council of BOA Me. (DCB) was founded to support **“The BOA Initiative”, which is REPARATIONS FOR US BY US, NOW!** A Decentralized Bank is a bank within the people represented by a Googolplexian Token and governed by the face value, and terms of the QR code (Code).

The BOA Me Transfer Agreement

BOA in all forms Digital and Reserved are transferred in good faith, at the established value of 1 Googolplexian USD (United States of America Dollars) further understood as “Universal Standard Denomination.” BOA embodies the intrinsic value of a Human Being. **Every transaction of BOA is a Divine act of love** for Humanity and reciprocal thereof. A transfer is an agreement to **“The Emancipation Treaty of BOA Me.”** **BOA is never truly bought or sold, only transferred and received with love.** The Holder is in an elite wealth class never before seen, coined as **“Guoplexian.”** **This level of wealth can only be obtained from the love of Humanity. All holders of BOA Digital and/or Reserved are Guoplexian.**

BOA Me Steps of Finance

Refinement

- Establish consensus bilaterally/multilaterally of the intrinsic value of BOA Reserved. **Based upon the value of a human being.** Via signing of the BOA Transfer Agreement.

Transfer

- Transfer 1 BOA Reserved according to the established value of 1 Googolplexian (USD) "United States Dollars", further understood as the **"Universal Standard Denomination"** to accepting Nations. As a Foreign Exchange (Forex) boost. **A historic Capital Transfer**, to represent Reparations for Chattel Slavery and Colonialism.

Use Examples we “Hope” for, BOA as humanitarian Capital to be exchanged for human needs and development.

- Purchase a Government Bond with 1 of the remaining Googolplexians. Collateralize that bond for cash/credit. Invest cash/credit in human development. **When the bond matures the cash pays the debt if a borrower defaults. While collateralized the bank/lender receives the coupon interest of the bond.**
- Exchange Googolplexian for cash and pay associated **fees, to be determined by the Government/bank as revenue.**
- Collateralize Googolplexian for credit, **interest rate to be determined by the Government/bank for Revenue.** Combination of all the above, and more.

The Great Nation of BOA Me (BOA)

The Great Nation of BOA Me is an African nation in exile, due to the “Economic System” of Chattel Slavery. The exile continues to this day. Our home is now wherever we are as Global Citizens. The Decentralized State of BOA Me

The Decentralized State of BOA Me is a collection of African Nations in Exile, due to the “Economic System” of Chattel Slavery. We are Aboriginal Nations of Africa, who have suffered a great dignity taking, which is still ongoing. However, we have unified in mind and spirit, via the high value of self and that of others. The Decentralized State BOA Me was created by African Descendants of the Enslaved and Allies of Justice. We possess a priceless “Asset” based upon the stolen wealth and dignity of our ancestors’ human capital. We were captured as prisoners of war, exiled from our homeland, enslaved, and systematically oppressed for centuries. We endured a great forced migration to our new homes in the Americas and Caribbean. All other knowledge of our Nation’s great history was systematically stripped from living memory.

The Decentralized State of BOA Me is like a forest. The Great Nation of BOA Me is but a tree; BOA Reserved is the Fruit, and BOA Tokens are the seeds.

The Code of BOA Me

Voting Rights

The supreme council of BOA Me will determine at will how many BOA Reserved are to be created up to 100,000, 10 exist thus far (2024). 100,000 represents the amount of Digital BOA Created for the Decentralized Bank of BOA Me. Requests and votes are highly considered. **Although no majority vote may override the Supreme Council of BOA Me. The Supreme Council holds Veto Powers and supreme authority over BOA Reserved price and minting.**

The Decentralized Bank of BOA Me can determine the face value of BOA Reserved with or without BOA Reserved in custody, via ownership of the QR Code “Code.”

The Code determines the standard face value and (Terms and Conditions) of BOA Reserved Token of Emancipation.

The Emancipation Treaty of BOA Me

Article 1. BOA Token is the reparations due to a group of Sovereign People that were enslaved. A people that paid the ultimate price of LIFE, and LIBERTY.

Article 2. The minimum value of BOA set forth is 1BOA=100,000,000x 1 USD. There is only 100,000 BOA in existence and not 1 more shall ever be created. The value may be raised or lowered to cover any debt, so long as it is agreed upon by 2 transacting parties.

Article 3. The value of BOA is such as humanity, **ALL FOR 1 & 1 FOR ALL**. Meaning the smallest increment is as valuable as all that exists and vice versa. **Just as all mankind are created equal by God.**

Article 4. BOA will be used **to eliminate wealth inequality for ALL PEOPLE regardless of, race, sex, or creed.**

Article 5. BOA will be accepted for **HOUSING, EDUCATION, AND BUSINESS DEVELOPMENT** by central banks and allies of justice.

Article 6. BOA exchanged for Fiat currency. Will pay interest up front as a loan and be taxed by the government as income.

Article 7. BOA Founders and participants are to respect the law of the land.

Article 8. BOA is **NOT** to be used to fund wars or violence.

Article 9. BOA IS IN NO WAY POLITICALLY AFFILIATED OR ALIGNED.

Article 10. Acceptance of this gift displays a WILLINGNESS to eliminate the colonial byproduct of systemic racism and wealth inequality.

Article 11. Acceptance of BOA is an Agreement to the Emancipation Treaty of BOA Me.

Article 12. "Acknowledgment of the Past for a Better Future Together". **ALL for 1 & 1 for ALL.**

The Great Nation of BOA Me Declaration of Sovereignty

The Great Nation of BOA Me exercises Inherent-Sovereignty, according to the powers vested by God almighty. From this day forward December 12, 2022, we declare the existence of this inherent sovereign authority the absolute right to govern, to determine our destiny, free of all outside interference, wherever located. We recognize that this declaration may not perfectly state our sovereignty's full and complete extent. Our sovereignty is based, not on the laws of human beings, but on natural laws given to us by our Creator; these natural laws are as they are, not as human beings may define them. God created us as sovereign beings. We have lived as sovereign beings since time immemorial.

However, a war has been waged against our Nation for the last 400+ years from approximately 1526 C.E. to the present day by many Nations. We were captured as prisoners of war, exiled, enslaved, and oppressed. Our populations were decimated, lands stolen, and the government dissolved by force. We have been severely oppressed, spiritually, mentally, physically, and economically for centuries. We are the last known survivors of a vanquished people. We are a displaced Indigenous African Nation. The forceful dismantling of our government has impeded our ability to negotiate peace terms.

We were never provided reparations for the effects of slavery and Jim Crow Segregation. Police consistently kill us even when unarmed. We are disproportionately incarcerated due to our race. Our ancestors were LYNCHED and TERRORIZED for political purposes. We are still economically oppressed and relegated to poverty. Our institutions are underfunded due to systemic injustice. Systemic racism persists. These are the conditions upon which we seek economic relations on our behalf. We are not American. We are a displaced aboriginal African Nation in the Americas. Removal of shackles is not freedom; the acknowledgment of our sovereignty is. Freedom is not allowed or given; freedom is honored and respected.

Each Nation Member retains personal sovereignty and the right to life, liberty, equality, justice, and the pursuit of happiness. **We make this declaration in order to inform all who deal with us, and future generations of Nation members, of the essential nature of our national sovereignty.** We seek peace with all belligerents. We hope to end all aggressions toward our Nation. We have no appetite for war or vengeance upon our enemies. We seek unity and cooperation with all peace-loving and justice-seeking Nations. However, we will defend our freedom and sovereignty if threatened. Hereby this document may forever serve as a relic to acknowledge the past for a better future together.
